



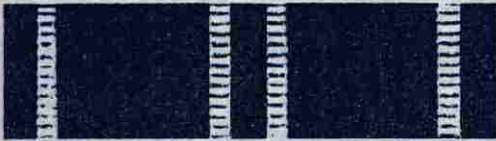

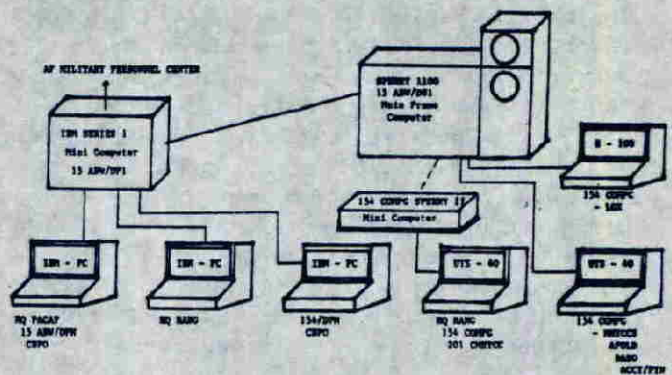

MSgt. Rolland Tang, the Computer Operations Supervisor, 154th RMS, will be in charge of the Sperry 11 which will be our main link to other computer systems. Maj. Edwin Chung-Hoon is chairman of the committee that will oversee installation and implementation of the system. Virtually every Guard unit will then be able to "interface" with other units and other computers with the installation of 19 terminals.

Just some of the benefits of this program will be transferring of information by electronic mail, communication interface and file sharing. The system should significantly improve, enhance and expedite data processing and communications for the 154 Composite Group.

We received our 1st Air Force Outstanding Unit Award for achievement during the period October 1978 to June 1979. We converted from F102s to F-4s and received an excellent rating from the PACAF IG team which highlighted the award period. We have since received our second Air Force Outstanding Unit Award for meritorious achievement by the Composite Group during calendar year 1982 and 1983. The consistent professional performance of all the units of this Composite Group explains our second selection for this prestigious award.

April marks the initiation of HANG's monitoring of physical fitness through tested walk/run standards. The program has been developed to encourage a disciplined self motivated physical fitness program. To insure that testing is conducted under safe standards, all personnel will first complete the medical questionnaire which will be graded by our medical staff. Those who are graded Group I will be able to participate in the entry program. Group II and II will await their testing pending further guidance from NGB. We expect to complete all testing by the end of August for the tested period FY85. Some of our fulltime personnel have already completed their testing.

April also marks a definite programmed period to prepare for our deployment to Clark Air Base, Philippines. 170 of our personnel will be busy getting ready for Combat Sage and Cope Thunder during the period 7-24 May. We plan to participate in this ambitious undertaking with 8 F-4Cs. As usual, the workday period

will be a long one since we will be simulating combat conditions. Nevertheless, the air combat scenario program for Cope Thunder justifies our commitment to this outstanding training opportunity. For those selected to participate, congratulations to you for the honor of being on this year's team.

PAY NOTES

April Drill Paychecks - We expect to input the April 13-14 UTA pay submission on 19 April 1985 to meet the 23 April 1985 computer run. Oahu units should insure that UTA rosters arrive at 154 RMS/ACFP (Military Pay) not later than 15 April 1985 and GSU units not later than 17 April 1985 in order to meet the above computer run date. The checks should be received and dated 30 April 1985.

Sure-Pay (Direct Deposit) - Recently we have had numerous calls from members regarding late receipt of their drill checks which is being sent to the member's home address because of the mail. Sign up for SURE-PAY and you will have your drill checks as well as all other checks for military duty sent to your checking or savings account on time. So see your unit administration or stop by the military pay office and sign up for SURE-PAY.

Revised Leave Procedures For AGR Members - Effective 1 April 1985 the Air Force implemented new leave procedures. Each unit has been sent a copy of the new procedures, so check with your unit administration if there are any questions.

Pay Inquires - On 25 March 1985, a letter was sent to all unit commanders requesting their assistance in screening all pay inquiries prior to the pay inquiry being sent to military pay, so if you have a pay problem and/or question, send your inquiry through your unit.

Rent-Plus Documentation - Recently there has been national coverage and command emphasis on the Rent-Plus program. Letters were sent to units identifying individuals that were required to send Rent-Plus documentation to this office. So far response has been good, and we appreciate the effort of all the units. Individuals such as the 199 TFS who immediately responded by submitting documents for 28 out of 31 individuals.

Give a rousing welcome aboard to Chaplain Robert Nagamine. Chaplain Nagamine is a McKinley grad ('71), with an AA from Kapiolani Community College and a BA in Psychology from the University of Hawaii at Manoa. 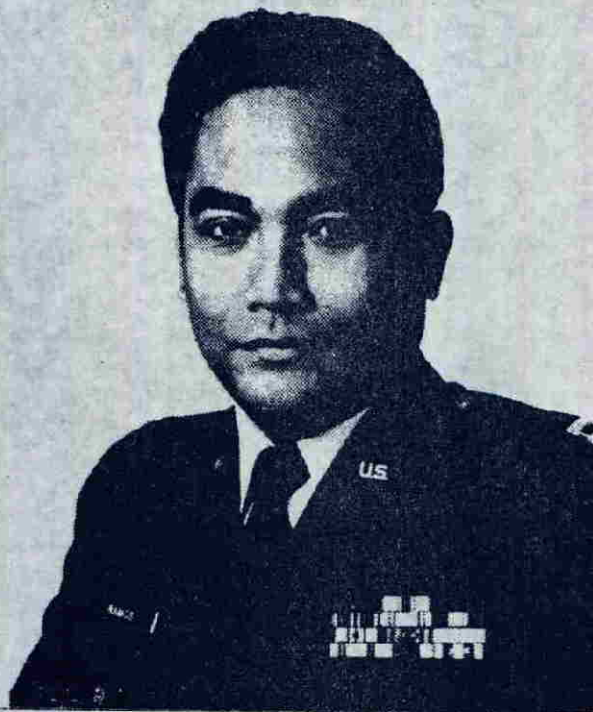

NEW G.I. BILL FOR GUARD MEMBERS

"Mom and Dad, are you concerned about how your son or daughter is going to pay for college? Did Uncle Sam pay for your education through the G.I. Bill? Here's a way for your young men and women to earn a college education or technical training while serving their community, state and country in the National Guard. Starting July 1, all qualified members of the Army and Air National Guard will be eligible for education benefits worth up to \$5,040.

Called the "New G.I. Bill," the federal program is for active and reserve component military members. Guard members are included in the act that grants money for college.

The Veterans' Administration will operate the program that will pay the money monthly, directly to the Guard member.

To earn the benefit, a person must join the National Guard and meet certain minimum qualifications. A recipient must be a high school graduate (or equivalent) prior to the end of initial active duty training. A person must serve at least 180 days in the National Guard, including initial active duty, and, a member must have at least six years of service remaining in the National Guard after July 1, 1985. Finally, a person must be enrolled in a VA-approved institution.

While eligibility for the program begins July 1, Guard members who enlist prior to July 1, 1985, and most current members, may also be eligible for benefits under the new program.

For example, a person may join the National Guard starting at age 17, usually for a six-year obligation to serve with a unit. The enlistment process and initial active duty (basic training and a military skill school) typically take four months or longer. Once the person finishes high school and passes the 180 day milestone of total National Guard time served, the member may apply for the educational benefit.

However, on or after July 1, 1985, current Guard members must reenlist, extend or otherwise agree to serve an additional time to make a total of six years to qualify.

The maximum benefit for a full-time student is \$140 per month for 36 months - \$5040 total. Students attending three-quarter time receive \$150 monthly and half-time students receive \$70. They may begin participating in the program after only six months of service. A person may use the benefit for 10 years from the first day of entitlement, or until separation from the National Guard, whichever comes first.

Regular pay and benefits for attending monthly training and two weeks of annual training continue, including any other state or federal programs open to the individual, such as the bonus program.

National Guard recruiting and retention officials located throughout Hawaii have complete details on this program and other benefits. Call Hawaii Air National Guard recruiters (Oahu: 449-5601; Hawaii: 961-6565; Maui: 244-0477; Kauai: 337-18 or visit any National Guard unit.

In Hawaii, Army and Air National Guard members are also eligible for the following state educational benefit: Enlisted Guard members and junior officers who maintain satisfactory performance are entitled to free college tuition if they enroll in an undergraduate or certificate program and meet other requirements established by the University of Hawaii at the Manoa campus, Hilo campus, West Oahu College, or any of the University of Hawaii community college on all islands."

TRAVEL UNRAVELED

Just to clear up any confusion, here's the word on travelling in uniform. Anyone travelling on DOD-controlled or owned aircraft must wear a uniform, whether leaving from a military or civilian airport. Uniforms are not required for official unofficial travel on commercial airlines. If you want to wear the uniform, it must be service dress (not utility) for men and women.

After graduation, Ko plans to attend the University of Hawaii where she will study liberal arts. After two years, she would like to transfer to a mainland college.

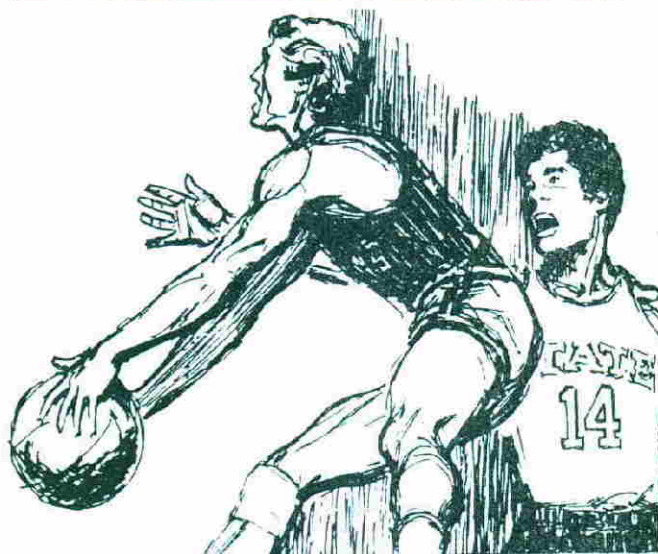
SAFETY NOTES

HANG STATE BASKETBALL TOURNNEY 1985

This year's state tourney was held 22-24 Feb on the island of Maui. It comprised of one team from Hilo, Kauai, and Maui, and also three teams from Oahu; 154 RMS, 199 TFS, and 154 CAM A.

We arrived on Maui the 22nd and started the morning of the 23rd. The first game was between the host team Maui and RMS. The game started all out Maui. They led 23-10 at halftime. The second half, though was a different story. RMS came out with new found energy and spirit and squeaked out a victory 34-33. It was a total team effort by RMS that pulled out the win. The host team then had to take its chances through the Losers' Bracket. 199 TFS and Kauai then gave us our first overtime game in Maui. This game was closely contested from start to finish. Kauai won 39-38. High point man was Don Almodova (Kauai) with 27 points. Play continued on with RMS vs CAM A. The winner of this game drew an automatic bye into the championship game on the 24th. Meanwhile, in the Losers' Bracket, Maui defeated 199 TFS to keep their hopes alive 36-24. Maui's Razo and Cabrera each contributed 10 points. Kauai defeated Hilo 35-34 behind Don Almodova's 22 points. Maui, with the home crowd backing them trucked up the Losers' Bracket one more inch by defeating Kauai 30-27. This was a run -n- gun game seeing

25-30 foot "jumpers" and many block shots. This set Maui in the semi-final against the loser of the CAM A/RMS game. That game, unlike the Kauai/Maui game, was very physical and more slow paced. Both teams started out feeling the pace and setting up their offenses. Position under the boards was crucial and tough to get. Maui players "hit the floor" as play got a little rough. At half-time RMS held a slim 17-16 lead behind Mike Soares 7 points. Tough defense by both teams kept scoring down. In the second half, play stayed intense. Both teams knew the importance of the game: automatic seat in the championship game. After all the sweat and dust had cleared, CAM A prevailed by the score of 29-26. High point man was Guy Fuentes (CAM A) with 14 points. The loss to CAM A hurt RMS worst then what was first seen. This was evident by the next game; a loss to Maui by the score 33-19. RMS settled in 3rd place.

This set up a championship game between defending champion CAM A and the host team all the way from the beginning of the Losers' Bracket, Maui. The game was the giant vs the underdog; Ala George and Villanova: but with a different outcome. The game started all Maui. They ran off the first eight points of the game. It was at this time that CAM A called a time-out to regroup and gather their senses and to sober up. It was a very important time-out by Coach Pahukula of CAM because his team ran off a streak of 9 unanswered points to lead 9 to 8. Play went back and forth with CAM A leading 11 to 14 at half-time. In the second half, Maui stayed close with jump shots and quick hands. CAM A held besides Maui's efforts and won 33 to 31. CAM A repeated as champions and did it in fine fashion. They executed well and had the best overall athletic talent. Our hats go off to them. Our five man allstar team was: Don Almodova; Kauai, Eduardo Gorospe; Maui, Guy Fuentes; CAM A, Chuck Manley; 199 TFS, and Mike Soares; RMS. Our MVP was Guy Fuentes; CAM.

Thanks go out to the Standing Committee on basketball, Iris Kabazawa; Tournament Director, Jimmy Pahukula, Co-Director, Marino Quitazol; Co-Director, Rose Vendiola; member and Pamela Guieb; member. From Apr. 16-18 the HANG will be hosting the Joint Surveillance System Region Operations Control Center (JSS/ROCC) Computer Program Configuration Sub-Board (CPCSB) at the 154 COMPG area. This board, which is chaired by Lt. Col. J. Sageser, HQ NORAD/J3PA, meets to act upon computer software change proposals and to discuss other topics of importance to the JSS/ROCC system. HANG PHYSICAL FITNESS PROGRAM



The ANG Physical Fitness Evaluation Program will be implemented during April - June 1985 for volunteers (low risk and conditioned personnel) will be conducted on an annual basis. All personnel are expected to participate in the program, except those granted a medical waiver by the 154 USAF Clinic physicians.

Individuals who are deconditioned from lack of regular exercises should start off on a gradual walking program and increase their distance in increments over a period of weeks until they can walk 3 miles within the allotted time. This will potentially reduce the risk of problems.

The evaluation will consist of one of the following methods, which will be at the choice of the individual being evaluated.

- (1) 1.5 mile run, jog or walk or combination thereof.
- (2) 3 mile walk (limited to walking only. Running or jogging results in disqualification.)

The performance standards in minutes and seconds for both methods are as follows:

For AGRs HOW LEAVE CAN BECOME AWOL

Three basic rules to remember:

First, leave starts and ends in the local area. Second, it starts on the day you insert as the effective date and ends on the last day of the number of days you requested. Third, you must be available at the leave address and telephone number you give on your leave form.

If any of these conditions change before you depart on leave or during leave, you should contact the person who authorized your leave. A common abuse of leave is departing on Friday or Saturday for a leave that begins on Monday. This violation could turn your leave into AWOL. If you were to have an auto accident many miles from your duty station before official leave begins, you or your surviving family could lose valuable benefits.

Don't trade your honor for a few hours of free time, It isn't worth the risk.

- * Numerous instances were observed wherein junior personnel did not address senior personnel with the proper forms of address.
- * Some aircrew members wore multi-colored or lettered undershirts.
- * Numerous aircrew personnel were seen with flight suits partially unzipped.
- * Numerous people were seen with fatigue shirts partially unbuttoned and with the sleeves improperly rolled.
- * Numerous people did not render proper courtesy to higher ranking officers upon their entrance into work areas.

We are all guilty of one or more of the cited discrepancy(ies). Some of these findings still exist today.

Let's work together and take positive steps to improve in these areas of concern.

have provided realistic combat settings working in conjunction with active USAF, USMC, USN units, the FAA and other Air Guard units.

Ten highly successful deployments have been cited as "contributing significantly to increasing member proficiency and (the) current state of combat readiness. During the two-year period indicated, 490 Group members participated in ten various deployments averaging, each, 15.6 days in length. Two particularly noteworthy deployments were the "Team Spirit" deployment of 6 F-4s and 168 members to Kunsan Air Base, Korea, March 8-21, 1983, and the Red Flag deployment of 6 F-4Cs and 89 crew members to Nellis AFB, Nevada, Mar. 6-20, 1982. The Group has also been commended for support rendered in the medical field (Clark Regional Medical Center and Yokota USAF Hospital), combat support, Prime Beef and the highly successful DOD-sponsored Air Launched Probe System (ALPS) Research Project conducted on Kwajalein Island. This last project resulted in considerable savings to the Government.

In 1983, the 154th Composite Group received the National Safety Council Award of Merit and the 169th AC&WS was presented the NSC Award of Commendation. The year before, the 150 AC&WS on Kauai was given the NSC Award of Commendation. The AC&WS were cited for their participation in a number of operations.
