

WE'RE GOING TO CHANGE OUR NAME!

Our 154th Fighter Interceptor Group will shortly be known as the 154th Tactical Fighter Group. The change will probably take place in July, as part of our transition from F-102 to F-4.

Although we will continue with our Air Defense role, we will be charged with Air Superiority. Our strength will increase by 120 persons, from 696 to 816 bodies. The largest increase is in CAMRON. The strength of the 199th FIS will swell slightly with the addition of Weapons Systems Officers being assigned to that unit.

OPEN HOUSE

Plans are now being made for the 4th Annual 154th family and friends day Open House during the Sunday UTA, August 15, 1976. The purpose is to foster a better understanding of the ANG and the roles which our members play by performing duty with their units. All Guardsmen are encouraged to invite their families, employers and friends. Tentative plans are to have the Open House from 1000 to 1430 hours with free lunch and beverages being served free to all visitors and Guardsmen. PRESIDENT FORD SIGNS RESERVES CALL-UP BILL INTO LAW

On May 14, President Ford signed into law a bill permitting quicker call-up of military reserves to active duty for a limited time.

The new law would permit the activation of 50,000 reservists and National Guardsmen for up to 90 days without the declaration of a national emergency or war. Defense officials said this law will help establish the credibility of reserve components and ease their integration into the defense structure.

Citing the "Awesome speed and technology of modern warfare," President Ford told persons at an Armed Forces Day dinner: "I signed into law a bill making our National Guard and Reserve units an even more significant part of our total force."

"Until today it took a national emergency or an act of Congress to put the Reserves into action," he said. "Under this new law, the President will be able to mobilize up to 50,000 of the selected Reserve for up to 90 days."

In the past, the reserve program has been hampered by a lack of modern equipment and the reluctance on the part of the active duty force to assign realistic, meaningful missions to the same reserve organizations. This reluctance stemmed from a concern that scarce equipment and important missions should not be allocated to units whose availability in time of crisis depended upon either a congressional declaration of war or a presidential declaration of national emergency.

This legislation provides a fast method of activating reservists for operational missions.

#### CREDIT UNION FOR GUARD

Effective March 24, 1976, all drill status guardsmen on Oahu were added to the field of membership of the Hickam Air Force Base Federal Credit Union and became eligible to participate in the various programs offered by it. Drill status members will be entitled to the same benefits and privileges offered to those already enrolled. They will be able to borrow, on signature only, up to \$2,500 or four times their net take home pay, whichever is smaller. Fact sheets describing other benefits will be distributed soon.

#### Hickam Military Clothing Sales Store

On 1 June 1976, the Army and Air Force Exchange Systems (AAFES) took over the operation of the Military Clothing Sales Store in Bldg T-1043.

The operating hours of the store are Monday - Friday: 1000 to 1800 and on Saturday: 0930 to 1700.

The store's merchandise is of two types: Those of the Defense Personnel Support Center (DPSC) and AAFES commercial items.

In our issuance/purchase of airmen clothing, we are authorized only the Defense Personnel Support Center items. These items are coded via yellow tags in the store.

Note that the store will not honor any purchase of AAFES items on our AF Form 656.

Certain gratis alteration services are available to airmen only.

Last month we ran a survey concerning smoking in the mess hall. Only fifty responses were received. This is not a large enough sample to be representative, so we cannot consider the results as valid. A better method of survey will be devised to reach a larger sample or personnel.

Human Relations Council

Whatever happened to? Just a little update on the human relations council. At the last meeting several ideas were kicked around; one of the ideas was to have a member of the council (preferably a younger airman) meet with prospective recruits to brief them on what to expect when they find themselves in the guard mainstream. It is felt that the recruits will relate better to a relatively new guardsman than to one who is older (and wiser?)

The council is also working on ratifications to current haircut standards within the different sections. Council members believe that it is very confusing to have several different standards for haircuts depending on whether you wear a wig or not, hat section you are attached to, and who is inspecting. It seems that people in the guard don't know what to expect from one drill to the next.

Remember, if you have any gripes don't hesitate to notify your sections HRC representative. It's their job to help.

If you don't know who your representative is, keep your eyes open. Their picture should be up on your bulletin board shortly.
