> (CAPSULE LAW) "... But I DIDN'T SAY HE COULD SELL MY CAR!!"

There's an old adage which states "It's not what you say but what you do that counts!" While this wise saving could apply to many "legal" situations, it certainly applies when you give someone power of attorney. This legal instrument is one in which you give other persons the power to act for you either for a particular transaction or for business in general.

Make sure what kind of power of attorney you are signing and give it only to those you trust. Give 'no more authority to act than is absolutely necessary. The authority you do grant ends when you die or when you specifically revoke it. If you do not limit the time, you may revoke it by destroying all copies or by specific written revocation to all who hold the documents to all persons with whom the holder of the power of attorney may attempt to transact business.
