Photo by TSgt. Dan Y. Kiychiro Randolph AFB said Lt. Nakano was a class leader who willing helped fellow students get through the tough program.



New Mexico F-16s Arriving This Weekend

The 154th Group will be hosting members of the New Mexico Air National Guard beginning this weekend. Eight F-16s from the 150th Fighter Group (150 FG) are scheduled to arrive Sunday, February 6 for two weeks of Dissimilar Aircraft Combat Training (DACT). The exercise, named Sentry Cactus, is an important element in maintaining the readiness of the 199th Fighter Squadron and the 150th FG to accomplish their air defense and air superiority missions. Sentry Cactus is one of several such exercises throughout the year that allows HIANG pilots to train with "opponents" flying fighter jets different from their own.



COMMANDER'S ACTION LINE

QUESTION: What happened to the HIARNG Band's Christmas Concert?

ANSWER: The ever popular event was not possible this past Christmas due to conflicting requirements on the band. The possibility of a spring concert is being discussed at State Headquarters. Hopefully, a Christmas concert will be possible again next year.

QUESTION: Are we ever going to have our coral parking lot paved?

ANSWER: We're working hard to see that happen. The HIANG wants to see it done as does the 15th ABW. Plans have been drawn that would create a Magic Island sort of setting with paved parking, curbing, and an ocean-front green belt. Money is the limiting factor, and if nothing else, we'll continue to make improvements incrementally, The next set are slated to be a part of the construction of the Composite Support Facility that will house the dining hall, hospital, CBPO and finance.

QUESTION: When is the 169th AC&W Squadron getting a permanent commander? It has been seven months since Lt. Col. Oka left the unit.

ANSWER: A nomination for the military commander/air technician detachment commander has been forwarded to State Headquarters for approval. Hopefully, we will be making a formal announcement of the selectee soon.

QUESTION: Ever since the "Cold War" ended, why does it seem that our everyday pace has picked up?

ANSWER: Good question, and the answer is a complex one that boils down to organization, equipment and mission. The ending of the

"Cold War" coupled with budget pressures are the events most responsible for the tremendous change taking place in the Air Force and the Air National Guard, though we're lagging by several years.

Organizationally, we want to look like the Air Force and are currently involved in reorganization to the "Objective Wing" structure. In a nutshell, the current resources and maintenance functions combine, part of the maintenance function goes to the flying squadrons and we end up with an organization consisting of an Operations, Logistics and Support Group, with an overall Headquarters.

As regards to equipment, Gen. Richardson, TAG Hawaii and our leadership at State Headquarters have been extremely proactive over the years in working with HQ PACAF, the NGB and our congressional delegations to insure we're postured to be a viable force well into the 21st century. We're seeing the results of those efforts now with MSIP F-15S being equipped with chaff and flare countermeasures and our undertaking several test projects to increase survivability and lethality. The KC-135R squadron, just a year old, will receive additional airplanes, doubling their size by this time next year. Finally, we expect to activate a C-130H Tactical Airlift Squadron with four aircraft by the end of this fiscal year. Coupled with the robusting/activation of the KC-135s/C-130s will be a debusting of the F-15 unit from 24 to 18 authorized aircraft.



Legal Line

For some reason, several people of late have asked me about getting a LIVING TRUST and/or a LIVING WILL. I have a feeling that some may be confusing the two instruments, so let's clear things up. This month, we'll do living wills

The living will, which actually is not a will at all, is a way of assuring that expensive and hopeless medical measures are not taken to needlessly prolong life where there is no hope for recovery. With the shield of a living will, noble, but perhaps financially ruinous procedures to postpone the inevitable death can be avoided in those cases where neither the patient or their loved ones would benefit.

The following is the format found in the Hawaii Revised Statutes:

DECLARATION

My instructions shall prevail even if they create a conflict with the desires of my relatives, hospital policies, or the principles of those providing my care.

If I should develop a terminal condition or a permanent loss of the ability to communicate concerning medical treatment decisions, with no reasonable chance or regaining this ability. I do not want to have my life prolonged. I would not want to be subjected to surgery or resuscitation. Nor would I wish to have life sustaining medicine or procedures. Instead, I request care, including medicine and procedures, for the purpose of providing comfort and pain relief.

CHECKLIST

I have also considered if I want tube feeding to be provided and have selected one of the following provisions by putting a mark in the space provided:

() I do NOT want my life prolonged by tube or other artificial feeding or provision of fluid by a tube if my condition is as stated of above.

() I DO want my life prolonged by tube or other artificial feeding and provision by fluids by a tube if my condition is as stated above.

If neither provision is selected or if both are selected, it shall be

If neither provision is selected or if both are selected, it shall be presumed that tube or other artificial feeding or provision of fluids by a tube are requested to prolong the declarant's life.

This declaration shall control in all circumstances.

I understand the full import of this declaration and I am emotionally and mentally competent to make this declaration.

154th Tac Hospital Changes Commanders



Carbon Monoxide Poisoning - Carbon monoxide (CO) is a colorless, odorless gas. It is a byproduct of incomplete combustion of organic material. Carbon monoxide is found mainly in smoking, internal combustion engines, and heating equipment. It is considered toxic due to its ability to combine with hemoglobin (Hb) thus, avoiding oxygen to be transmitted to the lungs and body tissues. This is CO poisoning.

Mild symptoms of CO poisoning (COHb levels of 10-20%) can be vague from mild headaches to drowsiness. Symptoms become severe when the COHb level is beyond 25%. (nausea, judgment impaired, coma, death).

A major source of carbon monoxide is tobacco smoke. Cigarette smoke contains over 2% of COHb. One pack smokers have 5-6% COHb in their blood. Two or three pack smokers have 7-9% COHb blood level and heavy cigar smokers may reach 20%.

When carbon monoxide is being emitted, effective local or general ventilation is necessary. Reducing carbon monoxide from internal combustible engines can be done by replacing them

with electric ones. Workers exposed to carbon monoxide producing equipment in a poorly ventilated area should protect themselves with a universal gas mask with appropriate filter.

During a rescue, remove the victim from the contaminated environment to a well ventilated one. Resuscitate, oxygenate, and transport to a medical facility immediately. The rescuer should wear a proper respirator before rescuing the victim to avoid also becoming a victim.



Missions are the third area driving the apparent change in pace. As the active force has downsized, the Guard has proportionally assumed a greater share of missions. On the flying side of the house, KC-135s and C-130s from the ANG operate worldwide, every day in support of the active force. The drawdown in Tactical Fighter Wing equivalents to 20 will have ANG fighters assuming an increased role in active force missions, also. The current strategy is one of sizing the military to engage in, and win, two "major regional conflicts" simultaneously. To do this will require early participation by the reserve forces. If nothing else, this alone will drive renewed interest in maintaining the highest readiness levels our training dollars will buy, and our daily pace.
