STANDARDS OF CONDUCT

Paragraph 12, AFR 30-30, requires that the Standards of Conduct in the regulation be brought to the attention of all personnel at least semi-annually. This article prepared by 15 AB Wg/JA is our means of keeping you informed in complying with the regulations.

May a member of the Air Force or a civilian employee engage in business offbase which involve the use of "inside information" gained through his Air Force job? May a Colonel sell insurance to a Captain off base? May a member of the Air Force or a civilian employee accept a gift of tickets to an entertainment event from a contractor with the U.S. Government? May a Staff Sergeant make a gift of nominal value to his Technical Sergeant supervisor on the occasion of his supervisor's marriage? May a member of the Air Force use his title in endorsing some commercial product for a fee? May an enlisted member accept an off-duty job?

These are only a few of the many questions which may or, depending upon the circumstances, should arise in the minds of Air Force personnel in the conduct of their daily affairs both private and official. The answers to these and numerous other questions concerning conduct may be found in Air Force Regulation 30-30, "Standards of Conduct," which is applicable to all Air Force personnel, including all civilian officers and employees (both of appropriated and nonappropriated fund activities) and all active duty military personnel. It also contains provisions concerning former officers of employees and reserve officers. All personnel are charged with knowledge of this regulation. Attachments to the regulation also digest various laws applicable to active duty and retired personnel.

In general, Air Force personnel are required to avoid conflict, or even the appearance of conflict, between their official positions and their private activities. Prohibitions on a wide range of other personal conduct are also included. Specific subjects dealt with in the regulation include transactions with present and former military and civilian personnel, membership in nongovernmental organizations, commercial soliciting by active duty members of the Air Force, assignment of reserves for training, conduct prejudicial to the Government, bribery and grafts, gifts or gratuities, contributions or presents to superiors, use of Government facilities, property and manpower, use of civilian and military titles in connection with commercial enterprises, outside employment of Air Force personnel, gambling and lotteries and indebtedness. There are also provisions implementing various conflict of interest laws and provisions dealing with special government employees, advisors and consultants and temporary or intermittent employees. Procedures for determining when Air Force personnel are required to submit the DD Form 1555, "Confidential Statement of Employment and Financial Interest" and the manner of filing are set forth in detail.

It is not possible to effectively summarize the numerous provisions in the regulation or statutes. Consequently, all personnel should review this regulation carefully. Additional clarification of the standards of conduct and conflict of interest provisions set forth in the regulation and related statutes, rules and regulations may be obtained from the Office of the Staff Judge Advocate, 15th Air Base Wing.

RECRUITING

This March through June started about 695 students and groups of our high schools, organizations and community colleges, engaged in vocational training, touring the Hawaii Air National Guard facilities at Fort Ruger, Hickam Air Force Base and Wheeler Air Force Base. The conduct of these tours were coordinated by SMSgt T. D. Hussey, ANG Recruiter. The personnel touring the facilities are vocationally oriented in their respective schools or organizations in electronics, electricity, radio or auto mechanics.

In addition to the conducted tours, presentations will be made at the high schools, community colleges and organizations, to educate each group on the Air National Guard program. It is estimated that about 1,655 individuals will be contacted during the period from March to June 1973.

Let's all cooperate and get the recruiting program on the road to success.

CIVILIAN KITCHEN POLICE

The NGB Air Comptroller's Office conducted survey of ANG units revealed that most units were in favor of civilian KPs. Hence, Field Training Sites were funded for the civilian KP program in FY 73 and most likely be funded again in FY 74.

The proposal to fund for civilian KPs at other locations, such as ours, during UTA periods is STILL BEING STAFFED within the NGB. The FY 74 ANG Budget does not include funds for UTA civilian KP program. Hopefully, FY 75 will include this "worthy" program.

SERVICEMAN'S GROUP LIFE INSURANCE PROPOSED AS GUARD INCENTIVE

Two proposed laws of special importance to National Guardsmen have recently been introduced to the 93rd Congress.

Sponsored by Senator James Allen of Alabama and Representative G.V. Montgomery of Mississippi, both bills would authorize extension of Serviceman's Group Life Insurance (SGLI) to reserve components, permitting Guardsmen and Reservists to buy this insurance at the same rate charged the active serviceman; approximately \$3.00 permonth for \$15,000 coverage.

The proposed legislation is seen as a start in providing the benefits that Department of Defense officials feel are necessary to keep reserve Forces manned in a "no-draft" environment.

Under the Total Force concept enunciated two years ago by Secretary of Defense Melvin Laird the National Guard and Reserve forces have assumed a much more important role in the National defense. Drastic cuts have been made in the Active forces. This new and more critical role has resulted in increased demands being place on the Reserve requiring that strength levels be maintained at an all time high. Hawaii Air Guardsmen are urged to write to the State's Congressmen encouraging full Servicemen's Group Life Insurance to the reserve, they are S. 383 and H.R. 8.25. "GUARDSMAN OF THE YEAR AWARDS"

The HNG NCO Association announces the establishment of two HNG NCO Association awards to called the "HARNG NCO of the Year" and "HIANG NCO of the Year." These awards will consist of \$125.00 in cash and will be presented annually to the most outstanding enlisted/airman of the Hawaii National Guard.

ELIGIBILITY REQUIREMENTS:

All enlisted members of the Hawaii ARNG and Hawaii ANG who are members of the HGN NCO Association are eligible for this award.

Recommendations will include, but not necessarily limited to the following:

- (1) Faithful and outstanding service in and to the Hawaii National Guard. Consideration should be given to attendance and participation in unit assemblies and Annual Training.
- (2) Voluntary contribution of time and effort for the betterment of his unit and/or the welfare of the Hawaii National Guard and to fellow Guardsman.
- (3) The individual's participation and accomplishments in his unit's recruiting efforts.
- (4) Manner of performance of duty to include demonstrated abilities in skills and knowledge of his military occupational specialty, qualities of leadership, acceptance of responsibility, cooperation, loyalty, military bearing and the ability to inspire the confidence of others.
- (5) Participation in civic and community activities or the rendering of other services to the public which help foster good public relations for the Hawaii National Guard.
- (6) Any other outstanding or noteworthy achievements such as awards or commendations, completion of extension courses, combat service and completion of service schools.

PROCEDURES

- a. Recommendations for the award of the HARNG NCO of the Year and HIANG NCO of the Year cash awards will be made by unit 1st Sergeants. Each Unit will be limited to one (1) recommendations.
- b. Recommendations will include all available noteworthy achievements and documents in support of the individual being recommended.
- c. All recommendations will be addressed to the "Chairman, Awards Committee, HNG Association, Fort Ruger, Honolulu, Hawaii 96816" not later than 31 May of each year, for consideration of the previous calendar year.

Awards Committee: An awards committee selected by the President, HNG NCO Association will review all recommendations submitted for the awards and determine individuals to be selected as "HARNG NCO of the Year" and "HIANG NCO of the Year".

Announcement of Selections: Announcement of individuals selected for these awards will be published in the minutes of the HNG NCO Association Council.

Presentation of Awards; The recipients of awards (Army and Air) will be presented their cash awards at an appropriate time and place to be determined by the HNG NCO Association Council.
