### FLIGHT AND EXPLOSIVE SAFETY AWARDS

The Air Force Inspection and Safety Center has selected the 154th Composite Group (HANG) as the recipients of the 1987 Flight and Explosive Safety Plaques.

The Flight Safety Plaque is awarded annually for meritorious achievement in mishap prevention and this is the fifth time the 154th has received the award since 1979. Outstanding operational accomplishments were the conversion of the F-4 to F-15 aircraft during the first nine months of this calendar year without any mishaps. The unit participated in dissimilar Air Combat training, Air Defense, and other training exercises while flying 1977 sorties. Most importantly, the Air Defense alert commitment continued without any interruption.

The Explosive Safety Plaque is awarded annually for outstanding achievement in, or contribution to, explosive safety and mishap prevention. The 154th has completed over ten years without an explosive mishap which is a result of excellent program management. Some of the actions taken to prevent mishaps were a result of the close working relationship with the 15 ABW Weapons Safety office. The Weapons Safety office and unit representatives are constantly looking for ways to promote safety. These methods include "Crosstell" bulletins and "Hi-lighting" the mishaps from other units and adopting their prevention methods

Based upon observing recent unit ORIs, there have been many changes which will make it harder to demonstrate our readiness. Two of the critical areas in which we will bear down on include mobility training and disaster preparedness requirements. Our preparation philosophy is to minimize reacting to events; each time we expose ourselves to new challenges, we uncover weaknesses which must be corrected to develop a smooth running machine.

I cannot overemphasize the need for involvement by all members of the Composite Group in preparing for an ORI:

(1) By being competent. You must know your job well and improve your skill level to professional standards.

(2) Insure a quality performance by adhering to technical data and checklists; this has become rather evident with the complexity of the F-15 aircraft.

(3) Commit yourself to achieve the optimum combat ready posture by resolving discrepancies as noted in previous inspections; be honest with yourself and with your organization.

(4) And last, but just as important..."Don't ever let the incorrigibles get you down". Commanders and supervisors must themselves be strong in mental stamina to outlast fatigue and disappointments. We don't have to practice "bleeding" but we should be prepared to overcome unpleasanties.

# CBPO CONNECTION

## PERSONAL APPEARANCE AFR 35-10

This is a correction to paragraph 3c and paragraph 4, of the 6 March 88 Kukailimoku.

## HAIR, OVERALL STANDARD

Must be clean, well groomed and neat. If dyed, the hair must still have a natural appearance. Hair must not be worn in an extreme or fad style or violate safety requirements. Hair must not touch eyebrows or protrude below the front band of properly worn headgear. EXCEPTION: Hair will be visible in front of women's beret, and may be visible in front of women's flight cap.

## HAIR STYLES (M)

Hair must have a tapered (conform to the shape of individual's head) appearance on both sides and back. Only closely cut or shaved hair on the back of the neck may touch the collar. Hair must not touch the ears and exceed 1½ inch in bulk. Visible foreign items may not be attached.

## HAIR STYLES (W)

Must be styled to present a feminine appearance. Hair may not extend in length below the bottom edge of the shirt collar. Hair must not exceed 3 inches in bulk or prevent proper wear of headgear. Plain and conservative pins, combs, and barrettes similar to the individual's hair color may be worn to keep hair in place. Ornamentations (ribbons, jeweled pins, etc ...) may not be worn.

## REQUIREMENTS FOR ID PHOTOS

Military members were required to wear their uniform for ID card photographs but now civilian attire may be worn. The title board must be placed high enough to ensure that no recognizable clothing is visible. When a title board is not required, any visible clothing in the photo must be a neutral tone such as grey, black, or white and have no discernible design.

## REENLISTMENT BONUS

The Bonus eligible AFSC list for 3rd quarter fiscal year 88 has been received. Effective April 1, 1988 thru June 30, 1988 the following five digit AFSCs qualify for a bonus:

25XXX	27XXX	30XXX	32XXX	36XXX
42XXX	43XXX	45XXX	46XXX	49XXX

Basic qualification remains the same. Manning must be below 100% for the specific AFSC; only one reenlistment bonus is authorized per eligible member; member must not be in an overage condition; members payda must not be over 10 years.

Members who qualify are also eligible for the Student Loan Repayment program. Any GSL, NDSL, or FISL student loans may be repaid at a rate of 15% or \$500 per year of satisfactory service. ## RETIRED RESERVIST SGLI

The Veterans Administration and the Office of the Servicemen's Group Life Insurance have set new premium rates for the cost of the Retired Reservist Program. The new rates are effective on the first policy anniversary date following April 1, 1988, for those retired reservist already participating in the program. For new enrollees the new rates are effective with separation dates of April 1, 1988 and later. The new rates, in increments of \$10,000 up through \$50,000, are shown below:

**CBPO CONTINUED****DD FM 93 - RECORD OF EMERGENCY DATA**

Guard members are required to ensure their DD Fm 93 is kept accurate and up to date. In the event you become a casualty, the Air Force will use your DD Fm 93 to enact prompt notification of your next of kin. DD Fm 93 must be updated when there is a change of marital status, spouse's address, parent's address, location of dependants, number of dependants, spouse's military status, and person or persons not to be notified due to ill health. Importance of this form cannot be over emphasized.

## SAFETY NOTES

### DEVIATING FROM SOP'S

A fatality occurred on a MAC base when a contractor employee deviated from standard operating procedures. The individual was crushed by an electrically driven horizontal moving hangar door. OSHA investigators came up with the following scenario: An aircraft had to be towed from the hangar. Operation was performed by only one person, the deceased. The door switch had an open and close button which must be manually pushed and held to operate doors. Doors travel from fully open to fully closed position in two minutes. Employee depressed the "close" button and wedged a screwdriver between the button and switchguard so doors would move without his assistance. As doors started to close, he operated the tug, with aircraft in tow, and exited the hangar. When clear, he got off the tug and went to retrieve the screwdriver. Doors were nearly closed by this time. However, he still reached inside to remove his screwdriver from the switch box and was trapped and eventually crushed by the door. LESSON LEARNED: We cannot afford to deviate from SOPs. We must continue emphasizing the importance of avoiding shortcuts and non-standard operating procedures.

## LEGAL BRIEF

A federal circuit court has denied the appeal of an Air Force Reservist whose handlebar mustache got in the way of his reenlistment eight years ago.

The court ruled against MSgt Jonathan J. Christian, who was denied reenlistment in the Reserves in 1980, after his commanding officer found that Christian's mustache did not comply with Air Force regulations.

Christian fought the decision before the Air Force Board for the Correction of Military Records, arguing that the commanding officer was merely requiring Christian to conform to his own personal

grooming standards."

The board rejected his claim ruling that commanders are "granted certain prerogatives" when applying regulations that are open to interpretation. In this case, Air Force Regulation 35-10 prohibits unusual facial hair.

Eleven months after his enlistment expired, Christian reenlisted. In the meantime he had shaved off his mustache and filed a lawsuit in U.S. District Court in Los Angeles.

He sought correction of his military records, back pay of \$7,000 and award of retirement points. The lower court dismissed his complaint because it dealt with the military's appearance code, which the court ruled should not be open to judicial interpretation.

The U.S. Court of Appeals for the Federal Circuit upheld the lower court's decision. In its March 3 opinion, the three-judge panel found that "it is clear that if Christian had trimmed or shaved his mustache he would have been allowed to reenlist."

Christian, who is 41 years old and still cleanshaven, is assigned to a unit at March AFB, California.

"It was a very, very small mustache, but the ends were curled out," said John Vaisey, Christian's attorney.



Vaisey said Christian is considering whether he will appeal. (Note: The above article was published by Vesta Kimble in the Air Force Times dated April 4, 1988).
