RECALL

The following rules will apply to all future practice or actual emergency mobilizations (Recalls):

1. All Group personnel will sign in at the centralized sign-in location on the hangar floor.
2. All Group personnel are expected to sign in within one hour of Recall time.
3. Personnel arriving later than one hour and thirty minutes from Recall time will sign in and be directed to report to their First Sergeant to provide an explanation for their delay.
4. A list of these personnel with their explanations will be forwarded to Group Headquarters by Recall time plus four hours.
5. Personnel arriving later than two hours after Recall time will not be allowed to sign in on the hangar floor and will be directed to report to their First Sergeant.

DISPENSARY NOTES

Sick call will be conducted from 0800 to 0900 hours and 1300 to 1400 hours daily, during camp, by the Dispensary. All personnel are reminded that they are required to bring their immunization records up-to-date. CHECK WITH THE DISPENSARY.
